

Terms and Conditions for The Inner Circle Membership

I. Introduction

1.1 These Terms and Conditions (hereinafter referred to as "T&Cs") govern the use of The Inner Circle membership (the "Platform") operated by TNE NETWORKS PTE. LTD. 2 Venture Drive, #19-21 Vision Exchange, Singapore 608526, henceforth referred to as "we," "us," or "our." The Platform offers various online services, including but not limited to digital content, virtual events, and community features (the "Services").

1.2 By accessing, subscribing to, or using the Services, you (the "User") agree to be bound by these T&Cs, our Privacy Policy, and any additional terms applicable to specific services. Your agreement constitutes a binding contract between you and TNE NETWORKS PTE. LTD.

II. Use of the Platform

2.1 The Platform is intended for professional and personal development purposes. Users are expected to use the Platform in a manner consistent with this purpose and in compliance with all applicable laws and regulations.

2.2 We grant you a non-exclusive, non-transferable license to access and use the Platform and the Services for your personal, non-commercial use, subject to these T&Cs.

III. Registration and Accounts

3.1 To access certain features of the Platform, you may be required to create an account. You agree to provide accurate, current, and complete information during the registration process and to update such information to keep it accurate, current, and complete.

3.2 You are responsible for maintaining the confidentiality of your account login information and are fully responsible for all activities that occur under your account.

IV. Payments, Cancellations, and Refunds

4.1 Fees for access to the Platform or specific Services will be specified at the time of purchase. All fees are non-refundable except as expressly set forth in these T&Cs.

4.2 Membership Commitment and Cancellation Policy

4.2.1 Commitment Period: By enrolling in the Inner Circle membership ("Membership"), you ("Member") acknowledge and agree to a one-year (12 months) commitment period beginning on the date of your Membership activation ("Commitment Period"). This commitment reflects the Member's dedication to personal and professional development and ensures access to the full spectrum of Inner Circle benefits, resources, and community engagements designed to support transformative growth.

4.2.2 Non-Cancellation: During the Commitment Period, the Member agrees that the Membership is non-cancellable and that all Membership fees are non-refundable. LTD reserves the right, at its sole discretion, to modify or replace any of the terms or conditions of this Membership Commitment and Cancellation Policy at any time. Any changes will be effective immediately upon posting to TNE NETWORKS PTE. LTD. website or direct communication to the Member, unless otherwise stated. The Member's continued participation in the Inner Circle Membership following the posting of any changes to the Membership terms constitutes acceptance of those changes.

4.2.6 Legal Acknowledgment: The Member acknowledges that this Membership Commitment and Cancellation Policy is part of the Terms and Conditions agreed upon at the time of Membership enrollment and forms a legally binding agreement between the Member and TNE NETWORKS PTE. LTD.

V. Intellectual Property Rights

Except as expressly authorized by these T&Cs, you may not use, copy, modify, or distribute such intellectual property in any way.

VII. Limitation of Liability

7.1 To the fullest extent permitted by law, we shall not be liable for any indirect, incidental, special, consequential, or punitive damages arising out of or related to your use of the Platform or the Services.

VIII. Dispute Resolution

8.1 Any disputes arising out of or in connection with these T&Cs shall be resolved through binding arbitration in accordance with the laws of Singapore. The arbitration shall be conducted by a single arbitrator mutually agreed upon by the parties.

IX. General Provisions

9.1 These T&Cs, together with any other agreements or policies referenced herein, constitute the entire agreement between you and TNE NETWORKS PTE. LTD regarding the use of the Platform.

9.2 We reserve the right to amend these T&Cs at any time. Your continued use of the Platform following any changes indicates your acceptance of the new terms.

9.3 If any provision of these T&Cs is found to be invalid or unenforceable, the remaining provisions will remain in full force and effect.

9.4 These T&Cs are governed by the laws of Singapore without regard to its conflict of laws principles.
